

Ordinance #2014-1146

**AN ORDINANCE OF THE BROUGH OF MANVILLE
TO ESTABLISH HANDICAPPED PARKING SPACES ON
COLORADO AVENUE AND BOESEL AVENUE**

BE IT ORDAINED by the Mayor and Council of the Borough of Manville, in the County of Somerset and State of New Jersey, as follows:

ON STREET HANDICAPPED PARKING

1. Handicapped Parking on Streets

In accordance with the provisions of N.J.S.A. 39:4-197.5, the following street locations are designated as handicapped parking spaces. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Division of Motor Vehicles, or a temporary placard issued by the Chief of Police. No other person shall be permitted to park in these spaces.

<u>NAME OF STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
Colorado Avenue	South	Beginning at a point 280 feet east of the eastern curblineline of South 18 th Avenue and extending to a point 23 feet east thereof
Colorado Avenue	South	Beginning at a point 324 feet east of the eastern curblineline of South 18 th Avenue and extending to a point 23 feet east thereof
Boesel Avenue	South	Beginning at a point 162 feet east of the eastern curblineline of Cooper Street and extending to a point 23 feet east thereof
Boesel Avenue	South	Beginning at a point 203 feet east of the eastern curblineline of Cooper Street and extending to a point 23 feet east thereof

2. **EFFECTIVE**



The purpose of this ordinance is to establish an area of handicapped parking spaces on Colorado Avenue and Boesel Avenue.




