AN ORDINANCE TO AMEND ORDINANCE #2009-1082
 ENTITLED “AN ORDINANCE TO PROVIDE FOR AND DETERMINE THE ANNUAL RATES OF
 COMPENSATION OF CERTAIN OFFICERS AND EMPLOYEES OF THE BOROUGH OF
 MANVILLE, COUNTY OF SOMERSET, STATE OF NEW JERSEY”

BE IT ORDAINED, by the Mayor and Council of the Borough of Manville, County of Somerset, State of New Jersey as follows:

- 1.) The following positions are hereby deleted from Section 1:

1a.) New Section 1a. entitled Temporary Seasonal Employees not to exceed five (5) consecutive months is hereby added as follows:

1b.) New Section 1b. entitled Temporary Seasonal Employees not to exceed ten (10) consecutive months is hereby added as follows:

Not to Exceed Ten (10) Consecutive Months

Clerical Worker	\$15.00/hour
Public Works Laborer	\$15.00/hour

1c.) New Section 1c. entitled "Temporary Seasonal Employees Definition". Temporary Seasonal Employees are defined as employees whose duties are considered temporary and/or seasonal in nature. All Temporary Seasonal Employees will not receive health benefits, vacation days, holidays, personal days, sick days, or any other employee benefits. Temporary Seasonal Employees may be hired for either a five- or ten-month duration, however, the Borough of Manville may at any time end the employment of a Temporary Seasonal Employee without prior notice.

STATEMENT OF PURPOSE

The purpose of this Ordinance is to amend certain sections of Ordinance #2009-1082 in order to clarify Temporary Seasonal Employees and establish the maximum rate of compensation for temporary positions.
