

**Ordinance #201 8-\_1196**

**AN ORDINANCE AMENDING ORDINANCE #2008-1073  
TO REGULATE THE COLLECTION AND DISPOSAL OF  
BULK TRASH ITEMS, GARBAGE, MUNICIPAL WASTE AND SOLID WASTE  
WITHIN THE BOROUGH OF MANVILLE**

BE IT ORDAINED by the Mayor and Council of the Borough of Manville, in the County of Somerset and State of New Jersey, as follows:

1. Ordinance #2008-1073 (as previously amended in part by Ordinance #2017-1180 and Ordinance #2017-1185) shall now be further amended by modifying and amending sections 3.C. and 7.B. of Ordinance #2008-1073, to increase the cost for bulk waste stickers from \$2.00 to \$3.00.

2. Section 3.C shall now be amended to read as follows:

**SECTION 3. INCLUDED USERS AND CHARGES:**

C. Each bulk trash sticker shall cost \$3.00. This cost may be amended from time to time by the Mayor and Borough Council to reflect additional costs associated with the removal and disposal of bulk trash.

2. Section 7.B shall now be amended to read as follows:

**SECTION 7. QUANTITY OF CONTAINERS:**

B. The initial price of a sticker for additional garbage bags shall be \$3.00. The price for the sticker maybe amended from time to time by the Mayor and Council.

3. Except as amended or modified herein, Ordinance No. 2008-1073, as previously amended by Ordinance No. 2117-1080 and Ordinance No. 2018-1185 shall remain full force and effect.

4. Severability: In the event that any provision of this ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such

declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.

5. Inconsistency with other Ordinances: Should any provision of this ordinance be inconsistent with the provisions of any other prior ordinances, the inconsistent provisions of such other prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

6. Effective Date: This ordinance shall be effective ten (10) days after final approval and publication in accordance with law.
