

ORDINANCE #2018- 1203

**AN ORDINANCE AMENDING SCHEDULE "IV" OF
ORDINANCE NO. 500, KNOWN AS THE TRAFFIC
ORDINANCE, AS AMENDED ;
AND AMENDING ORDINANCE NO. 2018-1197**

WHEREAS, N.J.S.A. 39:4-138.6 provides that a municipality may mandate by ordinance the permissible distance a person may park a motor vehicle from a crosswalk, side line of a street or intersecting highway, or "stop" sign; and

WHEREAS, the location set forth in Section 1 below provide for a parking stall to be located within 20 feet of a crosswalk; and

WHEREAS, this governing body finds said distance to be permissible based on the characteristics of the location in question;

NOW, BE IT ORDAINED by the Mayor and Council of the Borough of Manville in the County of Somerset and State of New Jersey, as follows:

SECTION 1. AMENDMENT OF SCHEDULE IV - LIMITED TIME PARKING

Schedule IV of Ordinance No. 500, as previously amended by Ordinance No. 2018-1197, is hereby amended to include the following under the stated designations:

<u>NAME OF STREET</u>	<u>TIME</u>	<u>LIMIT</u>	<u>SIDE</u>	<u>LOCATION</u>
South 6th Avenue	Anytime	1 Hour	East	Between a point 31' south of West Camplain Road and 40' southerly there from for 2 marked parking stalls

SECTION 2. INCONSISTENCY

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

SECTION 3. SEVERABILITY

In the event that any provision of this ordinance, or the application of thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or

application of this ordinance which may be given effect, and, and to realize this intent, the provisions and application of this ordinance are declared to be severable.

SECTION 4. PURPOSE OF CAPTIONS

Captions contained in this ordinance have been inserted only for the purpose of facilitation reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

SECTION 5. EFFECTIVE DATE

This shall be effective immediately upon final adoption, approval and publication in accordance with law.
