

**ORDINANCE #2018-1205**

**AN ORDINANCE OF THE BOROUGH OF MANVILLE  
TO AMEND ORDINANCE NO. 500, KNOWN AS  
THE TRAFFIC ORDINANCE**

**BE IT ORDAINED** by the Mayor and Council of the Borough of Manville that, pursuant to the authority vested in the Borough by N.J.S.A. 39:4-197(1)(f), Ordinance No. 500 be and hereby is amended as follows:

1. **AMENDMENT OF SCHEDULE II.** NO PARKING CERTAIN HOURS:

Schedule II of Ordinance No. 500 is hereby amended to include the following under the stated designations:

North 4th Avenue	7AM to 4PM	Mon-Fri	West	At a point starting 50' from the north curbline of Brooks Boulevard to the south curbline of Louis Street in a north/south direction

2. **AMENDMENT OF SCHEDULE X:** LOADING ZONES

Schedule X of Ordinance No. 500 is hereby amended to include the following under the stated designations:

<b><u>NAME OF STREET</u></b>	<b><u>TIME</u></b>	<b><u>DAYS</u></b>	<b><u>SIDE</u></b>	<b><u>LOCATION</u></b>
North 4th Avenue	7AM to 4PM	Mon-Fri	West	At a point starting 50' from the north curbline of Brooks Boulevard to the south curbline of Louis Street in a north/south direction

3. **INCONSISTENCY**

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

4. **SEVERABILITY**

In the event that any provision of this ordinance, or the application of thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not effect any other provision or application of this ordinance which may be given effect, and to realize this intent, the provisions and application of this ordinance are declared to be severable.

5. **PURPOSE OF CAPTIONS**

Captions contained in this ordinance have been inserted only for the purpose of facilitation reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

6. **EFFECTIVE DATE**

This shall be effective immediately upon final adoption, approval and publication in accordance with law.
