An Ordinance to amend #2018-1211, An Ordinance to amend
Ordinance #500 known as the Traffic Ordinance

Statement of Purpose

The purpose of this Ordinance is to amend Ordinance #2018-1211 to correctly identify Borough streets and Schedule 2 of the Ordinance #500

WHEREAS, Ordinance #2018-1211 was adopted on November 26, 2018; and

WHEREAS, Ordinance #2018-1211 amended Schedule 1 of Ordinance 500 to prohibit parking for the following:

SCHEDULE I. NO PARKING: is hereby amended by adding thereto the following:

| <u>NAME OF STREET</u> | <u>SIDE</u> | <u>LOCATION</u> |
|------------------------------|-------------|--|
| North 2 nd Street | West | From Brooks Blvd. to Louis St. from 10:00 p.m. to 6:00 a.m. |
| Louis Street | South | North 2 nd Street to North 3 rd Street from 10:00 p.m. to 6:00 a.m. |

WHEREAS, said Ordinance #2018-1211 mistakenly cited North 2nd Street and North 3rd Street in place of North 2nd Avenue and North 3rd Avenue; and

WHEREAS, said Ordinance #2018-1211 should have amended Schedule 2 of Ordinance #500

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Manville in the County of Somerset, New Jersey “(the Borough)” that:

SCHEDULE 2. NO PARKING: is hereby amended by adding thereto the following:

| <u>NAME OF STREET</u> | <u>SIDE</u> | <u>LOCATION</u> |
|------------------------------|-------------|--|
| North 2 nd Avenue | West | From Brooks Blvd. to Louis St. from 10:00 p.m. to 6:00 a.m. |
| Louis Street | South | North 2 nd Avenue to North 3 rd Avenue from 10:00 p.m. to 6:00 a.m. |

This ordinance shall take effect upon enactment and publication in the manner prescribed by law.
