

Ordinance #2020-1238

An Ordinance Of The Borough Of Manville, In The County Of Somerset, New Jersey, Providing For Sewer Utility Improvements And Related Expenses In And For The Borough Of Manville And Appropriating \$25,000 Therefore From The Sewer Capital Improvement Fund Of Said Borough.

Statement of Purpose

The purpose of this Ordinance is provide for Sewer Utility Improvements and expenses from Sewer Capital Improvement Fund in the amount of \$25,000

BE IT ORDAINED by the Borough Committee of the Borough of Manville in Somerset County, New Jersey as follows:

Section 1. The Borough of Manville in Somerset County (herein after referred to as “Borough”) is hereby authorized to acquire the following equipment for Manville Borough and make the following improvements to Manville Borough sewer utility:

A. Purchase of equipment, including but not limited to sewer pumps and related equipment:

CAPITAL IMPROVEMENT FUND:	
SEWER PUMPS & IMPROVEMENTS	\$25,000

Section 2. The work, acquisitions or improvements authorized by Section 1. of this Ordinance (the estimated cost of which is noted opposite each item of work, acquisition or improvement) shall be undertaken as a sewer general improvement, the entire cost of which shall be contributed and borne by the Borough as a sewer general expense, and no part of said cost shall be specially assessed against any property. The estimated cost noted opposite each item of work, acquisition or improvement is not to be interpreted as either a maximum or minimum amount to be expended for the item; however, the total cost of said items shall not exceed \$25,000 unless this Ordinance is amended.

Section 3. It is hereby determined and stated that the undertaking of the aforesaid work, acquisitions or improvements (hereinafter referred to as “purpose”) is not a current expense of the Borough; and that the total estimated cost of said purpose is \$25,000 estimated cost for each specific item having been noted in Section 1 above.

Section 4. The sum of \$25,000 appropriated for said purpose from the sewer capital improvement fund of the Borough for said purpose as required by law and now available therefor under a budget or budgets of the Borough previously adopted.

Section 5. The sewer capital budget of the Borough is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith.

Section 6. This Ordinance shall take effect upon its passage and publication as provided by law.
