**Statement of Purpose**

The purpose of this Ordinance is to regulate parking in Municipal parking lots.

**BE IT ORDAINED** by the Mayor and Council of the Borough of Manville, County of Somerset, and State of New Jersey that Ordinance #500, as amended by Ordinance #628 and #1149 be further amended as follows:

**SECTION 1. ARTICLE XII**, Sections 12-1 through 12-6 of Ordinance #500 are hereby repealed and amended to read as follows:

Section 12-1 Any parking lot owned by the Borough of Manville, including, but not limited to the three parking lots located at 325 North Main Street – (Main lot, southeast corner lot and west lot located between North 1<sup>st</sup> Avenue and North 2<sup>nd</sup> Avenue,) the Manville Public Library lot and the South Main Street Parking Lot (located between North Orchard Street and Rosalie Street) shall be subject to the provisions of Subtitle 1 of Title 39 of the Revised Statutes of New Jersey.

Section 12-2 All vehicles parked within any of the said parking lots shall be parked between the marked stalls.

Section 12-3 There shall be no parking at any time by any vehicle with a registered gross weight of four tons or more in any of the said parking lots.

Section 12-4 No trailer or camper of any type shall be parked within any of the said parking lots.

Section 12-5 Whenever snow has fallen and the accumulation is such that it covers the parking lot area, no vehicle shall be parked therein until the removal of the fallen snow has been completed.

**SECTION 2. CONSTRUCTION**

Where consistent with the context in which used in this ordinance, words importing the singular shall include the plural; words importing the plural shall include the singular; and, words importing one gender shall include all other genders.

**SECTION 3. INCONSISTENCY**

Should any provision of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of said prior ordinances are hereby repealed, but only to the extent of such inconsistencies.

**SECTION 4. SEVERABILITY**

In the event that any provision of this ordinance, or the application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.

**SECTION 5. PURPOSE OF CAPTIONS**

Captions contained in this ordinance have been inserted only for the purpose of facilitating reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

**SECTION 6. EFFECTIVE DATE**

This ordinance shall be effective immediately upon final adoption in accordance with law.
