

**Ordinance #2020-1246**  
**An Ordinance To Amend Ordinance No. 500, Known As The Traffic Ordinance**

**Statement of Purpose**

An ordinance amending Ordinance No. 500, known as the Traffic Ordinance

**BE IT ORDAINED** by the Borough Council of the Borough of Manville, County of Somerset, New Jersey as follows:

**1. Schedule II No Parking Certain Hours**

No parking certain hours is hereby amended by removing thereto the following:

<b><u>Name of Street</u></b>	<b><u>Sides</u></b>	<b><u>Times</u></b>	<b><u>Location</u></b>
13 <sup>th</sup> Avenue (North and South)	Both	2am-6am	Between Dukes Parkway and Roosevelt Avenue.
Brooks Boulevard	North	8am-4pm	Between North 4 <sup>th</sup> Avenue & North 5 <sup>th</sup> Avenue.
Brooks Boulevard	North	8am-4pm	Between North 9 <sup>th</sup> Avenue & North 13 <sup>th</sup> Avenue.
Brooks Boulevard	Both	2am-6am	Between North Main Street & North 15 <sup>th</sup> Avenue.
Dukes Parkway	South	6am-9am 3pm-6pm	Beginning 130 feet west of the westerly curb line of North Main Street and extending west to North 1 <sup>st</sup> Avenue.
Knopf Street	South	2am-6am	Between North Main Street and North 13 <sup>th</sup> Avenue.
Roosevelt Avenue	South	2am-6am	Between South Main Street and South 20 <sup>th</sup> Avenue.
Washington Avenue	South	2am-6am	Between South Main Street and South 14 <sup>th</sup> Avenue.

No Stopping or Standing is hereby amended by removing thereto the following:

Washington Avenue (West)	Both	¼ hour	9am-6pm 9am-9pm	M-W Th-F	Between a point 35 feet west of South Main Street and a point 100 feet east of South 2 <sup>nd</sup> Avenue.

## 4. Schedule XVII Exits


Exits are hereby amended by removing thereto the following:
