

**Ordinance #2020-1251**

**An Ordinance Authorizing As A General Improvement The Acquisition And Installation Of A Generator By The Borough Of Manville And Appropriating \$48,207.00 Therefore From The General "Capital Improvement Fund" Of Said Borough**

**Statement of Purpose**

**The purpose of this Ordinance is to Authorize as a General Improvement the Acquisition and Installation of a Generator and Appropriating \$48,207.00 from the Capital Improvement Fund.**

**BE IT ORDAINED** by the Borough Council of the Borough of Manville in Somerset County, New Jersey as follows:

**Section 1.** The Borough of Manville in Somerset County (hereinafter referred to as "Borough") is hereby authorized to acquire the following items for Manville Borough and make the following improvements to Manville Borough facilities:

A. Purchase and Installation of a Generator

**Section 2.** The work, acquisitions or improvements authorized by Section 1 of this Ordinance (the estimated cost of which is noted opposite each item of work, acquisition or improvement) shall be undertaken as a general improvement, the entire cost of which shall be contributed and borne by the Borough as a general expense, and no part of said cost shall be specially assessed against any property. The estimated cost noted opposite each item of work, acquisition or improvement is not to be interpreted as either a maximum or minimum amount to be expended for the item; however, the total cost of said items shall not exceed \$48,207.00 unless this Ordinance is amended.

**Section 3.** It is hereby determined and stated that the undertaking of the aforesaid work, acquisitions or improvements (hereinafter referred to as "purpose") is not a current expense of the Borough; and that the total estimated cost of said purpose is \$31,707.00 estimated cost for items having been noted in Section 1 above.

**Section 4.** The sum of \$48,207.00 appropriated for said purpose from the "Capital Improvement Fund" of the Borough for said purpose as required by law and now available therefor under a budget or budgets of the Borough previously adopted.

**Section 5.** The capital budget of the Borough is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith.

**Section 6.** This Ordinance shall take effect upon its passage and publication as provided by law.
